



Registration form and important information on the inclusion in the crisis-manager database of the German Food Federation - Lebensmittelverband Deutschland e.V.

Please read the following information on the database, the rules for inclusion and data entry, the data protection statement and the exclusion of guarantee and liability and confirm your consent on the registration form.

General information on the crisis-manager database of the German Food Federation

This online database represents the first central, sector-wide and broadly available network that quickly and efficiently provides crisis-management information to all affected parties in crises.

Contents of the database

The database contains the contact data for companies' responsible crisis managers and their representatives. In addition, the database provides information about individual operational sites / branch locations, including postal codes, Federal State, type of operation involved and product categories.

Via a simple search function, operational sites (for example, key sites during a crisis) can be quickly selected, hit lists with contact data for crisis managers can be printed out and e-mail messages can be sent directly to crisis managers.

As of May 2008, the database also contains contact data for supreme monitoring authorities of the Länder – including crisis-centres and situation rooms for calls outside of regular working hours - and selected staff of authorities have access to it.

What kind of data is being stored?

- Address of the company
- Federal State
- Type of business: e.g. producer, manufacturer or distributor
- Product category: The products being produced or distributed by the company/operational site are divided into 35 categories, e.g. non-alcoholic beverages or desserts
- Contact data of crisis managers: telephone, mobile phone and fax numbers, hotline numbers, email addresses (at least one telephone number is mandatory)
- Addresses of other operational sites
- Up to two crisis managers per operational site

Data management

The companies, laboratories and associations represented in the database enter and manage the data for their own crisis managers. The companies specify up to two people responsible for the data management who keep the data up-to-date. These data managers receive writing permission for their company's entries.

Access authorisation

In general, the crisis-manager database is available to all food-sector companies and adjacent sectors.

At the same time, access to the database has been restricted as necessary in keeping with needs of data protection. Only crisis-managers as well as selected staff of the supreme authorities of the Federal States (Oberste Landesbehörden) may access the database.

Lebensmittelverband Deutschland e.V.

The Lebensmittelverband Deutschland e.V. - the German Food Federation - is the leading association of the German food sector. In this role, it represents the food sector throughout the entire production chain, "from farm to fork". Its membership includes some 90 associations, representing the areas of agriculture, food trades, food industry and food sellers; 100 individual members and 300 companies – ranging from midsized firms to international corporations.

The Lebensmittelverband Deutschland deals with a wide range of issues and areas, all of which fall under the somewhat abstract and general terms "food law" and "food science". Examples of more specific relevant topic areas include food safety, hygiene, labelling, health claims, additives, genetic engineering, quality assurance, food supplements and organic foods.

The registration in the crisis-manager database is independent of a membership in the association.

Data entry by data managers

Login data

After registration is completed an email will be sent to the data managers containing the required login data; a manual on the entry of data and handling of the database is available for download.

Data entry

Your data should be entered into the database within 14 days. If no entry is made within this period, your access will be blocked for safety reasons.

Your data is not visible to other users of the database until you enter your company's contact data and that of your crisis manager(s).

Please enter the necessary contact data to ensure a 24h availability of your crisis managers.

Up-to-dateness of data

Data managers are responsible for keeping the data up-to-date. When a different person is appointed as crisis manager or the contact data has changed, the corresponding data should be updated immediately.

Login data of crisis managers

As soon as the contact data of crisis managers have been entered into the database the crisis managers will receive the password for the access to the crisis manager database from the Lebensmittelverband Deutschland.

The Lebensmittelverband Deutschland stores name, email and telephone number (company) of crisis managers in a separate address database solely for administrative purposes, to ensure the functionality of the crisis manager database and to enable contact to companies and contact persons entered into the database.

A crisis manager's manual on the handling of the database is available for download.



Data protection

The crisis managers' and their representatives' contact data stored in the crisis-manager database serves the sole purpose of facilitating contacts to companies in crisis, to their responsible crisis managers and their representatives.

The Lebensmittelverband Deutschland attaches great importance to the security of contact data, as provided by users of the crisis-manager database, for crisis managers and their representatives, as well as to the security of stored information about individual operational sites / branch locations, including postal codes, German state (Land), type of business involved and product category.

For this reason, and in keeping with the intent behind the database, such data is stored solely for the purpose of enabling access-authorized persons to view it and to use it to make necessary contacts in crisis situations. Under no circumstances may such data be processed and used for other purposes. Needless to say, database data may not be provided to third parties.

All persons authorised to access the crisis-manager database promise to use the database data only for the purposes for which the database was established.

The Lebensmittelverband Deutschland stores name, email and telephone number (company) of crisis managers in a separate address database solely for administrative purposes, to ensure the functionality of the crisis manager database and to enable contact to companies and contact persons entered into the database.

Consent: If personal data has been entered into the crisis-manager database on the legal basis of consent (Article 6 (1) a DSGVO), the data subject has the right to revoke this consent at any time.

Revocation: In case of a documented consent revocation, the corresponding data set will be removed from the database without delay. Already shared information of that data set is not affected by the consent revocation, as it was processed at a time of an existing and valid consent and falls under Article 7 (3) sentence 2 DSGVO.

Your personal data stored will be deleted regardless of a revocation if it is no longer needed for the purposes for which it was stored or if you revoke your consent to your data being stored. Data will also be deleted if its storage is not permitted for other legal reasons.

The registration fee is 300 euros (+ VAT) once.

Access to the database is free of charge for members of the Lebensmittelverband Deutschland.
